This position supports the year-round operations of the Recreation Department. This position consists of supporting the operations in the department's three key areas: Lifeguarding, Fitness, and Activities.

This position may provide care, supervision, guidance, or control of children or may have regular, ongoing contact with children that is integral to the responsibilities of the position. As a result, in accordance with Pennsylvania's Child Protective Services Law, newly hired candidates are required to obtain the following clearances: a report of criminal history from the Pennsylvania State Police (PSP), Child Abuse History Clearance from the Department of Human Services (Child Abuse), and Fingerprint-based federal criminal history submitted through the Pennsylvania State Police or its authorized agent (FBI). Completed clearances are required to be submitted prior to starting employment.

Prioritize the safety of guests at The Hotel Hershey while providing courteous, friendly, and professional assistance in all Recreation operation areas.*

Oversee and enforce swimming pool and attraction rules and safety regulations.*

Organize and host a variety of family activities and events (bingo, s'mores roasts, Kids' Club, etc.), engaging guests of all ages while ensuring the guests are safe.*

Monitor the safe use of the Fitness Center while maintaining Forbes standards for cleanliness and service.*

Assist recreation attendants with guest questions, concerns, or complaints through knowledgeable communication and problem solving. Follow up by phone as necessary to ensure resolutions have been met.*
